

# WELLINGTON FACULTY OF HEALTH BOARD Te Wāhanga Tātai Hauora

### **Terms of Reference and Constitution**

Person Responsible: Pro Vice-Chancellor (SHEADI)

Chairperson: Dean of Faculty of Health

#### **Purpose:**

- (1) To provide a forum for the discussion of matters relating to academic and research matters relevant to staff and students in the Faculty of Health.
- (2) To advise the Academic Board, the Pro Vice-Chancellor (SHEADI), the Dean, the Vice-Chancellor and the committees of the Academic Board on all aspects of the academic qualifications, academic programmes and research matters for which the Faculty has responsibility and on any other academic and research matters which may be referred to it.

## Scope:

- (1) To advance and maintain the quality of academic programmes.
- (2) To originate and consider proposals, to initiate new programmes and courses and to delete or change existing programmes and courses, and to forward recommendations on those proposals to the Senior Leadership Team and the Academic Committee.
- (3) To monitor the implementation of the University's academic statutes, policies and regulations in the academic programmes for which it has responsibility, and in particular, matters relating to:
  - · the curriculum, teaching, student workloads and assessment of courses
  - the admission of students to programmes and courses
  - scheduling and timetabling of courses.
- (4) To oversee the development of Faculty-specific research policy, including policy on postgraduate student research.

(5) To consider and report on any academic matter including those referred to it by the Vice Chancellor, the Pro Vice-Chancellor (SHEADI), the University Research Committee, the Academic Board or the committees of the Academic Board.

#### **Constitution:**

- (1) Dean of Health (Convenor)
- (2) Associate Deans of the Faculty of Health
- (3) The Heads of Schools within which there are academic programmes for which the Faculty has responsibility
- (4) All academic staff members whose teaching and research contributes to the academic programmes for which the Faculty has responsibility<sup>1</sup>
- (5) All directors of the Faculty's academic programmes who are not members of the academic staff
- (6) All directors of the Faculty's research centres who are not members of the academic staff
- (7) A member of Toihuarewa
- (8) Manager, Student and Academic Services
- (9) Four (4) students currently enrolled in an academic programme for which the Faculty is responsible, appointed by the Convenor on the nomination of the relevant student body and including one (1) Ngai Tauira representative and one (1) PGSA representative
- (10) Other persons as determined by the Convenor.

#### In Attendance:

- (1) School and Research Centre Managers, Faculty of Health
- (2) Senior Faculty HR Adviser
- (3) Representative/s of Māori and Pasifika Student Services
- (4) Finance Advisor, Health
- (5) Senior Communications and Marketing Advisor, Health
- (6) Associate Director, Student Academic Services, Recruitment and Orientation or Representative
- (7) A Subject Librarian, nominated by the Librarian
- (8) Student Representation Coordinator, VUWSA

## **Comments:**

- 1. The Faculty Board will meet at least four times per year.
- 2. An Associate Dean, nominated by the Convenor, will deputise for the Convenor when required.
- 3. The Pro Vice-Chancellor (SHEADI), the Vice-Provosts (Academic & Equity) and (Research), the Deputy Vice-Chancellor (Māori), the Assistant Vice-Chancellor (Pasifika) and the Director of the Centre for Academic Development receive papers and may attend by invitation or at their own request.

- 4. Faculty Board members as detailed in (3), (5) and (6) of the Constitution, and Heads of research centres who are part of the academic staff are required to attend meetings and to nominate an alternate if unable to attend.
- 5. Ten voting members shall constitute a quorum at any meeting of the faculty and more than fifty percent of those members must be academic staff of the Faculty.
