# STUDENT CONDUCT STATUTE

Received:

a Council paper from the Provost, Professor Wendy Larner, dated 19 July 2022 regarding the Student Conduct Statute (document VUWC 22/88).

Noted:

- 1 that the Council paper was taken as read.
- that a review began in 2021 with the goal of ensuring the Statute reflects a maturing and strengthening of the University's commitment to the principles of restorative justice, the new Sexual Harassment Response Policy and Procedures, changes to the Pastoral Care Code that took effect in January this year, and a review of academic integrity issues.
- that extensive consultation had taken place with staff and students. The Academic Board had endorsed the proposed amendments at its recent meeting.
- that Council raised questions on the statute being completely silent on referring matters to the authorities, the general misconduct criteria around 'not in keeping with the Values of the University' and the definition of University precincts. It was confirmed that the University does not generally refer matters to the police of its own accord, that the broad definition under values has been supported by VUWSA and takes a standard legal analysis in working out if values have been breached, and in terms of precincts the Statute applies in three areas University premises, University activity (i.e. functions), and where misconduct directly relates to the University. With these explanations Council was unanimously in agreement with the proposed amendments.
- that the revised Statute will be launched in time for Trimester 3 and an education, training and communication plan is being developed to support the launch
- 6 that Ms Jackie Anderson was acknowledged and thanked for her work leading this review.
