## Making a difference



The University has been fortunate to receive bequests from alumni, former staff members, and those in the wider community.

Bequests have helped support students who face financial hardship studying for undergraduate and postgraduate qualifications across every school in the University. Gifts have nurtured research in fields from experimental physics to public health.

The Jack Pearce Postgraduate Scholarship in History, established in 2009, is funded through a generous legacy gift set up in memory of Jack by his daughter Brenda Joyce. Past recipient Louisa Hormann graduated with a Master of Arts in History in 2016. She now works as an archives technician at the Air Force Museum of New Zealand and has been elected to the board of Museums Aotearoa.

Some bequest donors specify that their gift be invested in an endowed fund that continues in perpetuity, earning investment income that will support their own aspirations and those of the University.


When you make an endowed gift to the Victoria University of Wellington Foundation, it will be wisely invested for the benefit of students and the University now and in the future.

By doing this, Roger has ensured that his scholarship will continue far into the future.

# Victoria University of Wellington Foundation

Your gift will be managed wisely and with great care.

Through the generosity of donors like you and earnings from endowment investments, more than \$50 million has gone to support the University in the 30 years since the Foundation was established in 1990.

We will ensure every philanthropic dollar you invest is disbursed according to your wishes. There are no administration fees and your gift may be eligible for a charitable gift tax rebate.

The Foundation is a registered charitable trust and has an independent board of trustees.

### Why make a will?

Your will is a legal document that records exactly how you wish your assets and possessions to be distributed after your death. By preparing a will, you can safeguard the future of the people and causes closest to your heart. You can have peace of mind knowing that your affairs are in order.

#### What is a bequest?

A bequest is a gift in a will. It is a way for you to support your loved ones and causes in the future without impacting on your financial needs during your lifetime. Once you have met the needs of your family, you could consider remembering Te Herenga Waka—Victoria University of Wellington with a bequest.

### Who makes a bequest?

Anyone can make a bequest. The University has received bequests from alumni, their families, former staff members and their families, and from people in the wider community. Their gifts have supported prizes and scholarships, teaching, and research across the University.

# What type of bequest can I make?

There are several options for leaving a gift in your will, including:

- the residue of your estate (what remains once all other gifts and costs are deducted)
- · a percentage of your estate
- · a specific sum of money
- a particular asset, such as property, art, shares, or an insurance policy.

## What to do next



Development Office staff are available to provide advice and apply your bequest according to your wishes. All discussions are treated in strict confidence.

We strongly suggest you seek the advice of a lawyer, the Public Trust, or a trustee company in the drafting of a new will or codicil to an existing will. These professionals can provide you with the advice you need to ensure your wishes are met.
