CA FAST-TRACK MPA PATHWAY

If your goal is to become a chartered accountant, you might be interested in our new CA fast-track MPA pathway.

This study pathway will grant you exemptions from six of the nine

courses in the CA programme through CA ANZ, which will significantly reduce the amount of study and the time it takes to become a chartered accountant. The CA fast-track MPA pathway can be completed in as little as 12 months of full-time study.

Upon completion of your university studies, you may apply for provisional CA membership through CA ANZ.

Additional three courses required for the CA fast-track MPA pathway

- ▶ MMPA 532 Financial Accounting and Reporting (7.5 points)
- ▶ MMPA 533 New Zealand Taxation (7.5 points) or MMPA 534 Business Performance (7.5 points)
