Background

The Brian Picot Chair in Ethical Leadership was established in 2016. It is one of seven professorial Chairs within Victoria Business School (VBS) planned around contemporary issues in specialised areas, namely digital government, public finance, business in Asia, economics of disasters, restorative justice, ethical leadership and wellbeing & public policy. The Brian Picot Chair in Ethical Leadership is hosted within Victoria Business School's, School of Management (SoM).

Professor Karin Lasthuizen is the inaugural Chair, having taken up the position on 1 November 2016 and Victoria Beckett commenced a position supporting the Chair on 7 February 2017 at 0.5FTE. This was increased to 1.0FTE on 1 May.

For the purpose of this report the term "Chair" refers to the team of individuals contributing to the position.

Role Purpose and Scope

The Brian Picot Chair in Ethical Leadership has the following purposes established within the memorandum of understanding (MOU).

A. Research

- a. Research on ethical leadership, including applying international research and expertise to New Zealand context;
- b. Supervision of graduate research projects and PhD research.

B. Teaching

- a. Teaching on leadership and ethics at all levels in the Victoria Business School, including the MBA within the School of Management;
- b. Providing leadership and guidance on how ethics is treated and included in relevant courses and overall teaching in the Victoria Business School;
- c. Presenting executive education for professionals.

C. Public Engagement

- a. Engagement with, and advice to, the corporate, public and community sectors including advice on ethics policies and ethics management;
- b. Writing media articles and being available for interviews;
- c. Management of visitor programme.

Advisory board

The Brian Picot Chair in Ethical Leadership is supported by an advisory board that includes senior representatives from Victoria University, partner and sponsoring organisations. The purpose of the advisory board is to enable the Brian Picot Chair in Ethical Leadership to engage in constructive dialogue with influential external stakeholders, in order to solicit useful and strategic advice that can help the holder of the Chair carry out the role. The Advisory Board consults with and provides advice to the Chair and the Head of the School of Management.

The advisory board met in December 2016 and three times during 2017 – in April, September and November. Mid 2017 we welcomed the new Dean of Commerce Professor Ian O. Williamson taking over from Professor Bob Buckle, who we are grateful for establishing the Chair. We were also very fortunate to have Philippa Foster Back attending the last two meetings in 2017. In addition, Lyn Provost met on a regular basis with Professor Lasthuizen to prepare advisory board meetings and 'to chew the facts'. All these conversations were extremely helpful for the Chair to maintain focus, become connected with external stakeholders, develop closer "town – gown" relationships and settle in at VBS and in community at large.

We are very thankful to all members of the Advisory Board for their time and effort to make this first year of the Brian Picot Chair in Ethical Leadership successful.

Academic research on ethical leadership

The **Ethical Leadership Challenge in New Zealand** is Professor Lasthuizen's initial research project as the Chair. The research aims to explore the meaning of ethical leadership and its role in addressing the main ethical issues in New Zealand. It will also seek to identify the potential role for the Brian Picot Chair in Ethical Leadership and the University to contribute in this area.

We have interviewed a group of 40 key people from the public, private and community sectors. The project commenced in 2017 and the interview phase was completed in early November. We have just started the analysis phase, in which the interview data will be coded and interpreted in software program NVivo. The research team is comprised of Professor Lasthuizen, Vicky Beckett and Marece Wenhold, who is also PhD student and teaching assistant in the School of Government.

The interviews serve as input for a book that introduces the work of the Brian Picot Chair in Ethical Leadership at Victoria Business School to a wider audience, and Professor Lasthuizen will share the initial outcomes of this research project during her inaugural lecture at Victoria University in 2018. In addition, academic publications on situational ethical leadership theory are foreseen.

We see this work as an ongoing project to introduce the Chair to new stakeholders and have open conversations about ethical leadership and its importance for the New Zealand context. In the future we hope to include comprehensive perspectives from large businesses and cultural perspectives.

Professor Lasthuizen is co-founder and on the Board of Directors of the international academic research network on Public and Political Leadership (PUPOL)

The second PUPOL international conference "Leadership for Public and Social Value" was successfully held on 6-7 April 2017 in Milton Keynes, UK – with about 90 participants. Professor Karin Lasthuizen was part of the closing forum, chaired paper sessions and presented two co-authored papers.

In addition, PUPOL is organising a Special Issue about 'Ethical Leadership and the Integrity of Public Institutions' for the Journal *Public Integrity*. Professor Lasthuizen is in the lead together with Dr Leonie Heres (USBO, The Netherlands) and Associate Professor Werner Webb (UNISA, South Africa). The Call for Papers will be send out before the end of 2017.

The Chair will slowly build a PUPOL Chapter for Oceania; including New Zealand's leadership researchers. We work closely together with Professor Brad Jackson (SoG; but moving to Griffith University in Brisbane, Australia in 2018 to take up a new position) and Dr Brian Spisak (Otago University). On 11-12 April 2019 the PUPOL Conference will be held in Wellington; this will be an exciting opportunity to launch PUPOL Oceania and bring insights from leading worldwide experts to New Zealand.

The Chair has been invited to join with Professor Chris Marshall, Diana Unwin Chair in Restorative Justice and his team to organise a **Conference on Restorative Justice and Ethical Leadership within New Zealand Corrections and Prisons**, 23-25 October 2018. This will include key themes around prison work, restorative justice and supportive ethical leadership. Professor Lasthuizen's previous work with Dr Toon Molleman and Hester Paanakker is highly relevant for this conference.


Analysing Survey Data. In 2017 our cooperation with external partners created opportunities to become involved in secondary data analysis of standardised survey data for New Zealand and include this research in academic and professional publications.

- The Brian Picot Chair in Ethical Leadership has been nominated as the New Zealand national partner for the global *Ethics at Work* survey 2018 from the Institute of Business Ethics (IBE).
 After the initial IBE survey report, the Chair will continue analysing the data for New Zealand, Australia and UK.
- We performed a pilot project involving an MBA student analysing Safe and Healthy Workplaces survey data from Orange Umbrella; unfortunately, this failed to come into being. New opportunities to continue our collaboration with Heidi Börner, Director of Orange Umbrella, through student projects are sought.

Research supervision of graduate research projects and PhD research

From Professor Lasthuizen's previous position in the Netherlands, **two Dutch PhD candidates** are brought that fall under her co-supervision. **Robin van Halderen** is in his final year and will finish his dissertation on noble cause corruption within the Dutch police force by the end of 2018; and **Jan Peter Gulmans** will commence his field study – in depth interviews with public sector officials who reported serious integrity violations within their work environment – in 2018.

Furthermore, Professor Lasthuizen served as a review committee member for the Dutch PhD thesis of **Imke Smulders** in October 2018. Imke's dissertation deals with the use of Twitter in community policing in the Netherlands. The public defense of the PhD thesis will follow in December 2017, although Professor Lasthuizen will not attend this meeting in the Netherlands.

During 2017 Professor Lasthuizen has taken on supervision of several students within Victoria Business School.

Both a talented Honours student and a Masters student started in July. Their theses have an ethics related theme.

Georgia Panagiotelis, Honours student, wrote her thesis on leadership development programmes.

Abstract: The focus of this study is the impact of leadership development programmes in training participants to become authentic transformational leaders. Six leadership development experts were interviewed in Wellington. New insights include the recognition of 'one size does not fit all' leadership training approach, use of group learning, significance of context, participant screening, need for participant effort, and fostering of an individual's true self. This study helps outline practices, and ways of approaching leadership development programmes, in order to develop authentic leaders for New Zealand's industry.

Hege Ovrebo, an international Masters student, will write her thesis about late Gen Y's expectations to ethics at work in New Zealand.

Abstract: The aim of the thesis is to explore the expectations the late Gen Y has to work and organisations in New Zealand, with a main focus on ethics. Late Gen Y (born 1992-1998) is the group entering the workforce now, and it is important for future employers and from a HR perspective to understand their expectations and address ethics issues in order to attract talent. Gen Y seem to be different from the previous generations and seem to have a more holistic view of ethics, as they grew up in a time of financial stability and a increased awareness of global warming and environmental issues such as natural resources running out. It is therefore argued that the late Gen Y are more interested in wider ethical issues, both at the organisational level, but also fair treatment and having a safe place to work. Focus groups, Q-study and interviews among respondents from this younger generation will be conducted during the first half of 2018.



Recently two international PhD students were brought to Professor Lasthuizen's attention and she gladly accepted the opportunity to co-supervise their theses within Victoria Business School's graduate program. Both students received financial support from their national government in form of a full time PhD scholarship for 4 years.

Dedy Eryanto, a government auditor from Indonesia, will start within the School of Management in December 2017. His thesis subject is 'The Effectiveness of Public Sector Integrity Systems in Indonesia' with as a Case study: the Audit Board of the Republic of Indonesia – BPK'. Co-supervising with Professor Tony van Zijl, School of Accounting and Commercial Law.

Quynh Huong Pham Nguyen, currently lecturer at the University of Transport and Communications (UTC) in Vietnam. Her thesis subject will cover sustainability, CSR and ethics within the construction sector, and will probably include a case study about SME's international trade between Vietnam and New Zealand. Co-supervising with Dr Nigel Isaacs and Dr Adele Lea from the School of Architecture, who will host Quynh Huong.



Providing leadership and guidance on ethics in the Victoria Business School

The Chair commenced a project to review ethics coverage in the VBS Curriculum. In the first phase of the project an extensive (excel) overview of courses that pay attention to ethics, CSR and/or sustainability themes has been produced, that also has been used for EQUIS accreditation purposes. For this phase the Chair was provided a research administrator by the School (Dr. Donatella Cavagnoli). The deadline was May 2017. In 2018 the Chair will further advise the School about how ethics is treated and included in relevant courses and overall teaching and what the strengths and weaknesses in the current Curriculum are; and also see this as an opportunity to bring the ethics crash courses under the attention of Heads of Schools and Programme Directors.

Professor Lasthuizen is a member of the **Principles for Responsible Management Education (PRME) Steering Committee** for Victoria Business School. The committee is chaired by Dr Christian Schott (who is the VBS representative for PRME). The steering committee works closely together with AVC (Sustainability) Associate Professor Marian van den Belt. Victora Business School is among the first Schools worldwide who became Advanced Signatory to PRME, see http://www.unprme.org

Among PRME Steering Committee tasks is advising the School how to improving responsible management education and raising awareness among staff and students about the 17 United Nations Sustainable Development Goals. One of the initiatives is a School wide 101 Course in Sustainability, in which the Chair will be teaching during 2018, to improve ethical reasoning capabilities among undergraduate students and provide an ethical leadership lens for management and policy problems.

Public engagement


Victoria Business School's location within the centre of New Zealand's thriving capital city and close to Parliament, Government departments and where many businesses have their head offices, provides an excellent opportunity for the Chair to engage with and form beneficial partnerships with public, private and community organisations.

The Chair's Administrator, Victoria Beckett, has a focus on engagement and started the year by compiling a database of contacts which will be merged with the University's central alumni and stakeholder database.

The six public events held during the year (see below - Events and public lectures in 2017) along with the 40+ contacts made during the Chair's initial research project generated substantial responses and helped to promote the establishment of the Chair and build the database of contacts. It is anticipated as the research outputs of the Chair increase during 2018 that Professor Lasthuizen will establish a greater presence within New Zealand media. Either through press releases announcing latest research and events or in response to requests to comment from journalists on key topics.

Working with the University's central marketing team a water themed brand image for the Chair was created and can be found as a banner image on the Chair's website, on event invitations and incorporated into pull up banners for the Chair.

A website has been created (www.victoria.ac.nz/ethical-leadership) within the School of Management and wider Victoria Business School website architecture. It will continue to be developed as an accessible repository for the research outputs of the Chair. The research, publications and resource sections will be expanded regularly, to include easily digestible 'bite sized' segments of useable information that can be translated back into everyday business. An example of this is the video shorts of the José Ugaz public lecture.

Management of a visitor programme

We intend to invite John Mathew Groot as the first fellowship/visiting scholarship of the Brian Picot Chair in Ethical Leadership. To explore opportunities and collaborations John will visit VBS in February/March 2018 for 2-3 weeks. The Brian Picot Chair in Ethical Leadership has been established with support from a private donor, the Gama Foundation and the Financial Markets Authority.

In the initial year of the Chair we remained within the financial budget, keeping \$50K in reserve for additional research assistance in 2018.
