REPORT FROM THE CHANCELLOR

Received:

a Council paper from the Chancellor, Mr John Allen, dated 26 April 2022 (document VUWC 22/38).

Noted:

- that student numbers are well below what the University had expected for 2022 and most other NZ universities have had a similar result. Reasons for this will be explored later in the meeting.
- that following the TEC Board Chair and senior officials attending the March Council meeting, work has continued on enhancing the success of Māori, Pasifika and disabled students in keeping with TEC's Ōritetanga Learner success programme.
- 4 that an update on recruitment of the University's next Vice-Chancellor was provided with the process reaching the 'sharp end'. Informal engagement with the Staff Advisory Group and the Te Aka Matua Committee panel will take place late next week leading to final interviews with Council in the week of 23 May. A vote to determine the successful candidate will be held

and this will be followed by reference checking and contract negotiations prior to an announcement.

REPORT FROM THE ACTING VICE-CHANCELLOR

Received:

a report from the Acting Vice-Chancellor, Professor Jennifer Windsor, dated 26 April 2022 (document VUWC 22/39).

Noted:

- 1 that the report was taken as read.
- that the success of Professor Claudia Geiringer, Professor John Townend, and Professor Bastiaan Kleijn being named three of the 2022 Ngā Ahurei hou a Te Apārangi Fellows, elected to the Academy of the Royal Society Te Apārangi for their distinction in research and advancement of mātauranga Māori, humanities, technology, and science was highlighted.
- that the recent death of Dr Moana Jackson (Ngāti Kahungunu, Rongomaiwahine, Ngāti Porou) was acknowledged. He leaves a significant legacy with his impact on the study of Māori law at Te Herenga Waka and the practice of Māori and Indigenous law throughout Aotearoa New Zealand and the world.
- that due to the late advice from the government of the change to orange under the COVID-19 protection framework, the planned May graduation celebrations at the Michael Fowler Centre and in the Hub could not proceed. A revised programme of events has been developed including the opportunity for graduates to have their photograph with the Chancellor, Acting VC at Pipitea Campus or the Pro-Chancellor and Provost at Kelburn Campus. There is also the opportunity to take part in a street parade from the Law School concluding at Civic Square with short speeches from the Mayor, Chancellor and Vice-Chancellor.
- that the Distinguished Alumni Awards celebration will proceed under orange at Te Papa on 20 May to recognise the achievements of six outstanding alumni.

- 4 that the University's current debt of \$36m was within the total debt capacity of \$150m. It was confirmed that debt has been paid down recently.

UNIVERSITY RESEARCH COMMITTEE REPORT

Received:

a Council paper from the Vice-Provost (Research), Professor Margaret Hyland, dated 26 April 2022 providing the University Research Committee report (document VUWC 22/41).

Noted:

- 1 that the report was taken as read.
- that in 2021, the Committee provided more than \$2.5 million in internal research funding and awards to Victoria researchers and postgraduate research students.
- that Council commended the ongoing growth in external research revenue (\$89 million in 2021), high profile awards and recognition internationally for staff in many fields and disciplines, growth in publication in high-performing journals, and strong numbers of doctoral students despite the ongoing impact of the COVID-19 pandemic.
- 4 that the work of Humanities and Social Science researchers, an area which accounts for a lower proportion of external research funding but is influential in the University's international rankings and reputation was acknowledged.
- that the discussion considered cross-divisional research barriers and opportunities, the interface between Wellington UniVentures (VicLink) and University researchers, the government's predicted white paper with possible changes to the funding model, as well as potential changes to Crown Research Institutes.
- 6 that Council thanked Professor Hyland and the University Research Committee for their work in producing an outstanding report with its clear links to the University's strategic priorities.
