NEW CONSTITUTION AND COUNCIL COMPOSITION

Noted:

- that the Chancellor detailed the process to reach this historic point today of approving the new Constitution and Membership Statute. He thanked all involved in the two rounds of consultation and especially acknowledged the work of the Chair of the Governance Committee, Dr Matthew Palmer.
- that the Governance Committee had met on 11 August and worked with delegated authority to recommend the new Council Constitution and Membership Statute. A consensus was reached and this was manifest in the documents tabled today.
- that the new Composition reduces the Council from 20 and must comprise 12 members as follows:
 - (a) 4 members appointed by the responsible Minister, by written notice to the Council, under section 171(1)(a) of the Education Act 1989; and
 - (b) 8 members appointed by the Council by resolution, in accordance with its statutes, under section 171(1)(b) of the Education Act 1989.
- 4 that the maximum number of occasions on which a person may be appointed as a member of Council is 3.
