Course Objectives

To teach economic applications of discrete-time deterministic and stochastic optimal control. Students passing this course should be able to

- solve linear difference equations;
- understand state-space models;
- build simple optimal-control type economic models;
- solve basic dynamic optimisation problems.

Readings

The text for the first eight lectures is J. B. Krawczyk "Conflicts over time: an easy application to dynamic games" ECON 406 and 407 Lecture Notes ("406" and "407" refer to old SEF honours course numbering). This is available from Blackboard. The remaining lectures will be based on Whittle and Ljungqvist & T.J. Sargent, see below. Some notes for those lectures will be also made available on Blackboard.

Materials and Equipment

You do not need any special equipment for this course. All numerical examples provided at lectures as well as the questions to be answered in assignments can be answered on a sheet of paper and using a pen (through calculus and algebra). However, knowledge of (and access to) Matlab or Maple will be of help to manipulate some more complex formulae. In examinations, you are allowed to use non-programmable calculators.

Assessment Requirements

Your course mark will be a weighted average of two assignments: 14%~&16% and the final exam: 70%

Final examination is open book; all questions are compulsory.
