Course Content

Material will be drawn from the following list:

- Manager-shareholder conflict
- Delegating monitoring to the board of directors
- Delegating monitoring to large shareholders
- Constraining management using capital structure
- Motivating management using executive compensation
- Market for corporate control
- Bondholder-shareholder conflict
- Adverse selection and signalling

Course Learning Objectives

By the end of this course, students should be able to:

- demonstrate an understanding of theories of corporate financing and corporate governance based on asymmetric information
- carry out simple empirical tests of these theories
- assess the merits of more complicated empirical tests of these theories
- interpret observed firm and market behaviour in terms of these theories
- communicate the key implications of modern corporate finance theories to a non-specialist audience

Course Delivery

Course delivery takes the form of 12 approximately two-hour lectures.

Expected Workload

The workload for FINA 402 is intended to be similar to that for other 400-level ECON and FINA courses. The total expected workload is 150 hours, comprising 12-13 hours per week.

Readings

There is no text. Lecture notes and key readings will be provided via Blackboard.

Materials and Equipment

Non-programmable calculators will be allowed in the final examination.

Assessment Requirements

The final grade will be determined by two assignments (each contributing 20%) and a two-hour final exam (contributing 60%).
