Course Delivery

Students are expected to meet with their supervisors on regular basis and deliver the final project on time.

Expected Workload

It is expected students will spend approximately 300 hours on their research. These hours are spread evenly over 12 teaching weeks and the mid-trimester break, averaging roughly 22 hours per week from the start of the course until the submission date of the project.

Prescription

A supervised research project that provides students with the opportunity to undertake independent research in a specific area of economics/finance.

Course Learning Objectives

- 1. To provide students with an opportunity to study in-depth, a topic area of interest.
- 2. To provide students with the experience of completing a significant research project in an intellectually independent and largely self-directed fashion.
- 3. To develop students' skills of critical inquiry and ability to write an academic paper that demonstrates an in-depth understanding of an area of research.

Course Content

The student will agree on a research topic with supervisor and undertake independent research in a specific area of economics, econometrics or finance. The final report should include an in-depth analysis of research question.

Readings

It is expected that all students will read and cite extensively the academic literature in their chosen area of research. The university library has extensive online access to journals.

Assessment Requirements

The assessment is 100% based on the final submitted project, which has to be uploaded to ECON-FINA530 Blackboard no later than **5pm**, **Friday 5 June 2015**. There will be no negotiation about deadline.

Your project may be used for quality assurance purposes, such as to assess the level of achievement of learning objectives as required for accreditation and audit purposes. The findings may be used to inform changes aimed at improving the quality of FCA programmes. All material used for such processes will be treated as confidential, and the outcome will not affect your grade for the course.
