Prescription and Context

Prescription

An analysis of tourism in the wider context of geographic, economic, political, technological, environmental and socio-cultural forces. Issues examined include: the evolving structure of tourism consumption, global economic growth, political and regulatory changes, technology advances, tourism globalisation and sustainability.

Context and Delivery

How do trends in society influence holiday choice or tourist consumption? This course explains and identifies the key trends that will shape the future of tourism whether they are political, economic, social, technological or environmental clustered around the themes of wealth, technology and resources. For example, personal disposable income, exchange rates and country GDP (Gross Domestic Product) influence the price of a holiday and how much money tourists spend on holiday, whereas the study of demography identities how different population cohorts i.e., families, youth or singletons all have different social attitudes and behaviours that influence tourism experiences from luxury to hedonistic activities. Using the process of trend analysis perspective, students examine the causes, speed of development and impact on tourism. This course predominately takes a global perspective of tourism rather focusing on New Zealand which is covered in *TOUR 108 An Introduction to Tourism in New Zealand*.

This course complements **TOUR101 Introduction to Tourism** by examining the underlying trends and events that shape tourist behaviour, choice and experiences.

Full and active participation in all activities is required for the successful completion of the course!

Students are expected to attend all lectures. Key themes will be introduced in lectures and followed up by discussion in tutorials and by reference to the wider literature.

Tutorials are a key part of the learning process and active participation in them is expected – the more you put in, the more you will get out of this course. Attendance at tutorials is also required to complete terms. **You must attend 7 out of 9 tutorials to complete the course**. Furthermore, you must always attend your allocated tutorial session; if you attend a different session, your attendance will not be recorded. Exemption from tutorials will only be accepted with a medical certificate or in exceptional circumstances.

Students can sign up for tutorials via an online sign-up system called **s-cube** at https://signups.victoria.ac.nz. Enter your SCS username and password to log into the system. Tutorial times show on **s-cube** and they commence in the second week of the course.

Items 1, 3,5, 6 from the list of skills will be assessed in the Assignment 1 (*Whakapapa*: Me and Tourism while Assignment 2 (**Tourism Portfolio**) will assess items will assess items 1, 2, 3, 4, 5 and 6 whilst the exam assesses 1, 2, 4, 5 and 6

Expected Workload

Students can expect the workload to be approximately 13 hours per week (20 pt course), including both scheduled contact time (lectures, tutorials etc) and outside class (including research time).

Group Work

Collaboration on individual assignments is not allowed beyond general discussion as to how one might interpret the nature of the assignment question. Please do not work together to formulate a response and do not loan out your completed assignments.

Mandatory Course Requirements

To fulfil the mandatory course requirements for this course you must:

- 1. Submit all assignments within 7 days of the due date
- 2. Obtain a grade of at least 40% on the final examination.
- 3. Attend 7 out 9 tutorials

Assignment 1 – Whakapapa: Me and Tourism (word limit 1200)

Whakapapa is a critical element in stating 'your' identity in Maori culture, therefore following the principles of whakapapa students identity 'who they are' and how tourism is portrayed using the dimensions of experience, cultural capital and authenticity. For example, France, wine and the Eiffel Tower or Maori, Haka and Te Puia. Mind map(s) are used to structure student's answers.

Assignment 2 – Tourism Portfolio (word limit 3000)

A series of learning questions will be posted on Blackboard each week to reflect lectures, tutorials and readings. Students are required to complete 5 learning questions using mind maps to capture the key points and explanations. The portfolio will conclude with a critical reflection demonstrating an interconnectivity of key tourism trends.

Students will be given further guidance on assignments during lectures and tutorials. Information will be posted to Blackboard

Examinations

Penalties - for Lateness & Excessive Length of Assignments

- (i) In fairness to other students, work submitted after a deadline will incur a penalty for lateness. The tourism management group has implemented a standardized late penalty for all tourism courses. Students who submit late assignments will be penalized at a rate of 5% per day (for example a one day penalty would result in a B 72% being adjusted to B- 67%). Saturdays, Sundays and public holidays will be included when counting the number of days late. Assignments received more than 7 days after the due date will not be accepted unless this has been discussed and approved by the course coordinator.
- (ii) Course Outlines provide a signal to students of forthcoming workload, dates of submission etc, and thus student study plans should take account of course requirements across all courses. Consequently, work load issues related to other courses and employment will not be accepted as reason for dispensation from mandatory requirements or waiver of penalties. **Extensions** to submission deadlines for any assigned work will only be granted in **exceptional circumstances.**
- (iii) Students who are unable to comply with any of the mandatory requirements should make a written application for an extension to the due date for submission of assigned work or for waiver of a penalty, **in advance**, to the course coordinator, providing documentary evidence of the reasons of their circumstances. All such applications must be made **before** the deadline wherever possible and be accompanied by documentary evidence, eg a medical certificate, or counsellor's report clearly stating the degree of impairment, and the dates the illness or event prevented you from undertaking your academic studies. This can be applied retrospectively.
- (iv) In the event of unusual or unforeseeable circumstances (e.g. serious illness, family bereavement or other exceptional events), that precludes an application in advance, students should make contact with the course co-ordinator by email or

- telephone as soon as possible, and make an application for waiver of a penalty as soon as practicable.
- (v) Word limits should be adhered to. The penalty will be 10% of the grade for an assignment which is 10% over the word limit (word limit includes everything apart from reference list and illustrative appendices).
