PAPER PRESCRIPTION

A detailed exploration of the key theoretical concepts and analytical approaches applicable to electronic music, from *musique concrète* and *Elektronische Musik* to the present day.

LEARNING OUTCOMES

A student completing this paper will have:

- an overview of the key theoretical concepts and analytical approaches applicable to electronic music
- 2. a critical understanding of core theoretical and analytical literature in the field
- 3. developed intermediate skills in the interpretation and formal analysis of electronic music
- 4. an in-depth analytical knowledge of key works of electronic music

PAPER CONTENT

Lectures will focus on key theoretical concepts and analytical approaches applicable to electronic music, as well as the application of these to key works in the repertoire. A series of practical assignments will allow students to develop ability in the analysis of electronic music and facilitate indepth exploration of a particular topic in the theory and analysis of electronic music.

ASSESSMENT REQUIREMENTS

Five percent (5%) will be deducted for written work that does not conform.

MANDATORY PAPER REQUIREMENTS

Prescribed reading and listening must be completed *before* the class for which it has been set. See Paper Schedule for details. All reading is from the MUSC 265 Anthology. Listening is from CDs available either from the AV Suite (Level 9, Main Library) or from the NZSM 265 class drawer (Office, Kelburn Campus).

Familiarity with Blackboard is a must for MUSC 265 as Blackboard will be used almost exclusively for submission and return of work, and will be the sole means by which students can access lecture notes, additional reading, assignment outlines etc.

Completing all the assessment items and attending at least 80% of your lectures and tutorials are a mandatory requirement for this paper. If for health reasons you are unable to complete all the work required for assessment purposes by 30 May you may, on presentation of a medical certificate, have the date for submission extended by the Director of the New Zealand School of Music.

ACADEMIC INTEGRITY AND PLAGIARISM

Acknowledging the use of musical materials produced by other people poses a special challenge for music students who are engaged in creative work. Your course co-ordinator will provide advice on how to avoid plagiarism in this circumstance.

Plagiarism is prohibited at the NZSM and is not worth the risk. Any enrolled student found guilty of plagiarism will be subject to disciplinary procedures under the Statute on Student Conduct and may be penalized severely. Consequences of being found guilty of plagiarism can include:

- an oral or written warning,
- cancellation of your mark for an assessment or a fail grade for the course,
- suspension from the course or the University.
