Course delivery

HIST 489 is a compulsory Research Essay undertaken in consultation with a HIST programme staff member. HIST 489 will have occasional support workshops for students in Trimesters 1 and 2. Although not compulsory, you are expected to attend these workshops and engage with other HIST 489 students about the research experience, organisation, and writing of your thesis. You are also expected to complete non-assessed in-class tasks as set by the coordinator. These workshops are run by the HONS course coordinator.

Course content

HIST 489 is a compulsory research essay undertaken in the completion of a BA (HONS) degree. The topic is devised principally by the student under the guidance of a HIST programme staff member. HIST 489 research essays should be around 10,000 words, approximately 40 pages of double-spaced typing, **excluding** footnotes and bibliography. The essays are mostly based upon primary source material, as opposed to the secondary material used in most undergraduate essays. Some HIST 489 essays, though, may be advanced historiographical essays.

Learning objectives

Students undertaking a HIST 489 Research Essay should be able to:

- Undertake a self-directed piece of research of 10,000 words and, ideally, to the standard of a quality, peer-reviewed article;
- Base their research on a wide reading of primary and/or secondary sources;
- Develop a solid and historically informed topic based on their research and advance a historically defensible argument about that research as it relates to existing historiography.

Expected workload

In accordance with Faculty of Humanities and Social Sciences guidelines, the overall workload for this course, as a Full Year course, is 300 hours in total.

Readings

There are no essential texts for HIST 489 research essay or for the workshop series.

Assessment requirements

The current criteria by which your HIST 489 essay will be assessed include:

• Your ability to develop and sustain an original piece of research over two trimesters;

- Your ability to conduct a literature search and to demonstrate an understanding of relevant secondary works, including books, articles, internet sources, etc;
- Your ability to formulate and address an historical question, to identify and interpret sufficient relevant evidence, and to generate clear conclusions that stress the importance of your findings and/or arguments;
- Your capacity to place any primary sources you use in an historiographical context;
- The extent to which you have presented the results of your research essay in clear prose within around 10,000 words; and
- The accuracy and consistency of your application of the conventions of historical scholarship. These include: the use of quotations; methods of citation, footnotes and bibliography; and may include the use of images, figures and data.

Please note that there is no mathematical correlation between your final grade and the above criteria. Your HIST 489 essay will be assessed as a coherent whole, not by assigning specific marks to these criteria. Rather than a restatement of the secondary material, or a narrative, or a mere 'reporting' of archival material, the essay should have a developed argument which takes account of previous work in the area.

Penalties

History Programme policy stipulates that late submission of essays is penalised. Students lose 5% for the first day late and 2% thereafter for a maximum of 8 days. After 8 days, work can be accepted for mandatory course requirements but will not be marked. Extensions may be granted in exceptional circumstances, but all extensions require the student to provide documentation. If granted an extension, students must agree to a new due date, but in the case of HONS, this will not exceed 7 days. Contact the HONS coordinator as soon as a problem emerges. Extension forms are available in the History Programme office. Please note that failure to submit your HIST 489 will result in a failure of the entire Honours year, irrespective if you submit work for all of your other courses.

Mandatory course requirements

To gain a pass in this course each student must:

- a) Submit the written work specified for this course, on or by the specified dates (subject to such provisions as are stated for late submission of work)
- b) Submit a work-in-progress report to the HONS coordinator and their supervisor (due 3 June 5pm)
- c) Present a 20-minute paper at the HIST 489 seminar presentations on the weekend of 21-23 July.

Return of assignments

Students will be advised by the HONS coordinator in late October or early November regarding collection of their HIST 489 Research Essay.

Class Representative

A class representative will be elected in the first class, and that person's name and contact details will be available to VUWSA, the Course Coordinator, and the class. The class representative provides a communication channel to liaise with the Course Coordinator on behalf of students.

Academic Integrity and Plagiarism

- Software programs and other electronic material
- Designs and ideas
- The organisation or structuring of any such material
