PAPER PRESCRIPTION

An examination of the main timbrally focused compositional approaches developed over the last 50 years in the realms of both instrumental/vocal music and sonic art. We pay particular attention to the composers Salvatore Sciarrino, Helmut Lachenmann and the Spectralist School, and explore a variety of microtonal approaches and methods of timbral analysis. Students express their research through a suite of creative and analytical projects.

COURSE CONTENT & DELIVERY

This course comprises two 1.5-hour lectures per week, and one 1.5-hour workshop per week. During workshops, classes will come together to listen to student performances, as well as presentations by staff and guest artists.

LEARNING OUTCOMES

Students who successfully complete this paper will be able to:

1. evaluate, and comment critically upon, the primary timbrally focused compositional approaches that have emerged in the last 50 years

2. evaluate critically issues in the use of timbre as a primary compositional material within their own creative work

3. analyse the role of timbre and gesture in a selected composition

4. employ timbrally focused sonic materials and techniques in a creative work

5. develop a disciplined, yet exploratory approach to extended techniques and timbral transformation of acoustic instruments.

PENALTIES

Sonic Arts work should be submitted as a clearly labelled Audio CD, or, for multimedia works, as a DVD or as a Quicktime data file on a data CD-ROM.

MANDATORY PAPER REQUIREMENTS

Each student must:

a) Complete each item of assessment.

b) Attend at least 80% of lectures.

c) Attend at least 9 Composer Workshops held during the term of enrolment in this paper.

If, for health reasons, you are unable to complete all the work required for assessment purposes for this paper by 4 July, you may, on presentation of a medical certificate, have the date for submission extended by the Director, NZSM.

EXPECTED WORKLOAD

A 20-point first-trimester paper should require at least 200 hours work (including class time).
