PAPER PRESCRIPTION

An introduction to the basic procedures of tonal music, including practical study of sight singing, rhythm reading, aural recognition of basic musical elements, and keyboard skills.

COURSE CONTENT & DELIVERY

This course comprises three 1-hour lectures per week and one 1-hour Musicianship Laboratory per week. During tutorials, a graduate tutor will guide students in discussion of course readings and/or set works, or assist with/give feedback on work in progress, where appropriate. Optional Clinics are also offered

- In addition, a CD of the musical examples given in the first two anthologies will be available from the lecturer on the presentation of a blank unopened CD-R.
- The Aural computer programme "Ear Conditioner" is an essential resource in this class, and is available for use in the keyboard lab when there are not classes present.

You will need to supply your own headphones for use in the Keyboard Lab.

LEARNING OUTCOMES

Students who have successfully completed this paper will be able to:

1. Add counterpoints in all five species to a given Cantus Firmus.

2. Harmonise a non-modulating melody for four-part choir using Diatonic chords including 7ths, and secondary dominants.

3. Identify by ear the basic properties of intervals, chords, and keys, and compare simple performances with the written score.

4. Use the keyboard to play simple pieces, transpositions, score readings, and improvisations.

- 3. Two tests each in Harmony and Counterpoint. Related to learning outcomes 1 & 2. (30%)
- 4. Two Aural Tests. Related to learning outcome 3. (15%)
- 5. Two Keyboard Tests. Related to learning outcome 4. (15%)
- 6. A Journal of responses to class material. Related to learning outcomes 1,2,3, and 4. (10%)

c) Achieve the threshold of 40% for each of Counterpoint, Harmony, Aural, and Keyboard.

If for health reasons you are unable to complete all the work required for assessment purposes for this paper by 4 July, you may, on presentation of a medical certificate, have the date for submission extended by the Director, NZSM.

EXPECTED WORKLOAD

A 20-point first-trimester paper should require at least 200 hours work (including class time). This means that in term time, the midterm break and study week you should be prepared to spend on average 13 hours per week involved in activities such as attending classes, reading, listening to recommended recordings and preparing assignments.
