#### **COURSE PRESCRIPTION**

Focuses on the research process, research concepts and the location implementation and critique of research in practice.

#### **COURSE CONTENT**

- Research questions and research design
- Research appraisal and utilisation.

- 2. Appraise evidence in relation to health related issues
- 3. Demonstrate advanced knowledge of different research approaches applicable to the health disciplines.

# **TEACHING FORMAT**

This course is delivered in two blocks over one trimester at the Graduate School of Nursing Midwifery & Health. The days will be a mix of lectures and small group activities. A distance component supported by Blackboard forms part of the course and supports student achieving their learning objectives.
