Course learning objectives (CLOs)

Students who pass this course will be able to:

1. undertake a self-directed piece of research of 10,000 words and, ideally, to the standard of a quality, peer-reviewed article;
2. base their research on a wide reading of primary and/or secondary sources;
3. develop a solid and historically informed topic based on their research and advance a historically defensible argument about that research as it relates to existing historiography.

Teaching format

HIST 489 is a compulsory research project undertaken in consultation with a History programme staff member. HIST 489 will have regular support workshops for students in trimester 1. The workshops are not compulsory, but attendance is expected. You should engage with other HIST 489 students about the research experience, organisation, and the process of writing the thesis. You are also expected to complete non-assessed in-class tasks as set by the coordinators. These workshops are run by the honours coordinators.

Mandatory course requirements

In addition to achieving an overall pass mark of 50%, students must:

- submit the written work specified for this course, on or by the specified dates (subject to such provisions as are stated for late submission of work. Specifically, students must:
 - submit a progress report;
 - present a 20-minute paper at the HIST 489 seminar;
 - submit the 489 research project.

Workload

In accordance with the University Guidelines, this course has been constructed on the assumption that students will devote a total of 300 hours to HIST 489. Over the 24 teaching weeks of the academic year, that is an average of 12.5 hours per week.

HIST 489 research projects should be around 10,000 words, approximately 40 pages of double-spaced typing, excluding footnotes and bibliography. The essays are mostly based upon primary source material, as opposed to the secondary material used in most undergraduate essays. Some HIST 489 essays, though, may be advanced historiographical essays.

Marking criteria

The criteria for assessing a HIST 489 essay currently include:

1. the ability to develop and sustain an original piece of research over two trimesters;
2. the ability to conduct a literature search and demonstrate an understanding of relevant secondary works, including books, articles, internet sources, etc;
3. the ability to formulate and address an historical question, to identify and interpret sufficient relevant evidence, and to generate clear conclusions that stress the importance of research findings and/or arguments;
4. the capacity to place any primary sources in an historiographical context;
5. the ability to present the results of historical research project in clear prose, and;
6. the ability to apply the conventions of historical scholarship accurately and consistently. Specifically, students must properly use quotations, citations, data, figures or images, and construct a bibliography.

Please note that there is no mathematical correlation between your final grade and the above criteria. Your HIST 489 essay will be assessed as a coherent whole, not by assigning specific marks to these criteria. Rather than a restatement of the secondary material, or a narrative, or a mere 'reporting' of archival material, the essay should have a developed argument which takes account of previous work in the area.

Submission and return of work

All written work must be submitted in hard copy to the History Programme office. **Two** copies of the final essay are required.

Please remember to keep a secure copy of all your assignments (whether in electronic or hard copy, or both).

Return of marked course work

The honours coordinator will advise students in late October or early November when they can collect their research projects.

Extensions and penalties

Extensions

Extensions may only be granted in exceptional circumstances, but **all extensions require the student to provide documentation**. If you begin to struggle, or have an illness or event that impacts on your work, please see your supervisor or one of the Honours coordinators as soon as possible.
