Prescription

This course will look at art and visual culture in the Pacific region (Polynesia, Melanesia and Micronesia) from the end of World War Two to the present. Topics examined will include art and nationhood, cultural revival, indigenous modernism and Contemporary Pacific art.

Course content

This course focuses on the relationship between art and visual culture and their changing contexts in the Pacific from the end of World War Two to the present. This period saw the demise of colonial empires and the emergence of independence and sovereignty movements in the context of global decolonisation. Towards the end of the twentieth century, there were further changes: the end of the Cold War and the 'triumph' of global capitalism, and the emergence of a mobile, pluralistic, interdependent world associated with postmodernity and globalisation. Ranging across this period, this course will examine topics such as the role of art in cultural revival, indigenous modernism, art and nationhood, tourism and the tribal art market, the changing role of museums and cultural centres, and the recent efflorescence of contemporary Pacific art within the global contemporary art world.

Course learning objectives (CLOs)

Students who pass this course should be able to:

- 1. critically view, analyse and interpret the art of this region within relevant historical, social, political and theoretical contexts;
- 2. gather and organise relevant information and evidence from published materials (i.e. secondary sources) and construct an argument using this material;
- 3. present material which is coherent and well-written and which demonstrates an understanding of the conventions of academic writing (including appropriate citation, referencing and documentation).
- 4. consistently apply the conventions of academic writing and art historical research

Teaching format

ARTH 336 consists of 24 one-hour lectures and 10 one-hour tutorials.

Mandatory course requirements

In addition to achieving an overall pass mark of 50%, students must:

- 1. Submit a credible attempt at TWO essays.
- 2. Attend a minimum of 8 out of 10 tutorials.
- 3. Sit the final examination.

Any student who is concerned that they have been (or might be) unable to meet any of the MCRs because of exceptional personal circumstances should contact the course coordinator as soon as possible.

Workload

The university recommends that 200 hours over the trimester, inclusive of lectures, tutorials and examination preparation, be given to a 20-point course in order to maintain satisfactory progress.

Typically, you will dedicate 34 hours to attending classes, 20 hours to reading for tutorials, 136 hours to researching and writing your essays, and 10 hours to revising course materials in preparation for the final exam.

Assessment

The course is assessed by means of TWO essays and a final examination. The first essay is based on close analysis of a single work of art. The second essay will allow you to range more broadly over the course content. The final examination will test your grasp of key ideas and concepts from the entire course and your comprehension and critical analysis of course readings. In this way, the assessment should ensure that you have a sound knowledge of as much of the course as possible. Marking criteria are available on Blackboard.

Submission and return of work

Essays should be placed in the art history assignment box in the foyer of Old Kirk, Level 3 (ground floor) on the due date. Note that you must attach a *signed* cover sheet to your essay. No essays will be accepted after 3 June. If you are in doubt about your ability to meet essay deadlines, you must see your course coordinator immediately. Essays will be marked by your course coordinator. A second opinion may be requested in the final assessment of any piece of written work. Marked essays will be available from the Art History office.

Extensions and Penalties

Extensions for the essay are possible if you are having serious difficulties completing your work. To receive a short extension, contact the course coordinator by email before the 5 pm deadline. For extensions longer than 3 days, you will have to provide written justification (e.g., a medical certificate, death notice, or letter from a counsellor, etc.). Extensions for the seminar presentations will only be granted in exceptional circumstances and with appropriate written documentation

Penalties will apply for late work. 5% will be deducted for work submitted more than 72 hours late; a further 2.5% will be deducted for each subsequent day. Work submitted more than 10 days late will not be marked; the work must still be submitted to meet mandatory course requirements. Late work receives only minimal comments from your marker.
