SECTION 2: COURSE INFORMATION

Prescription

This course will enable health care professionals to develop advanced skills in the interpretations, analysis and application of ethics and law in professional practice

Course learning objectives (CLOs)

Students who pass this course should be able to:

- 1. Examine and critique the ethical and legal aspects that are embedded within the healthcare context.
- 2. Evaluate the responsibilities of healthcare professionals in relation to perceived ethical and legal issues in healthcare.
- 3. Critically analyse the value to healthcare professionals of ethical and legal concepts, theories, codes and guidelines.

Teaching format

There will be 4 School days held in Wellington which will be delivered in two blocks of 2 days each over the trimester. The days will be a mix of lectures and small group activities. A distance component supported by Blackboard forms part of the course and supports student achieving their learning objectives. Online discussion groups are available to give students ways of continuing discussion about course material outside of the class room.

Workload

As a guide each 30-point course at the Graduate School requires students to allocate approximately 10 hours per point for self-directed study, research, assessments and attendance at Schools. Consequently 300 hours should be spread evenly over the 12 week trimester and mid-trimester break.

This course comprises approximately 32 hours of course contact time for lectures, group work and on-campus activities. The amount of time you should notionally assign to the completion for each of the assignments is as follows:

- 1. Assignment Number One: An examination and critique of the ethical and legal issues within the current healthcare context (30%): 80 hours
- 2. Assignment Number Two: Presentation of professional responses to a significant ethicolegal issue in practice (20%): 54 hours
- 3. Assignment Number Three: A critical analysis of a currently significant health care issue with particular emphasis on ethico-legal theoretical and applied perspectives (50%): 135 hours.

Assignment Number One

Assignment: Essay: Critique of the ethical and legal issues within the current healthcare context.

Due Date: 1 April 2016

Word Limit: 3000 words.

This assignment is worth 30% of your final grade

This essay focusses on those ethical and legal issues that significantly affect your own practice as a health care professional. That is, upon a significant issue and its subsidiary underpinnings that has or is currently of considerable interest to you in your workplace and/or professional studies.

You are requested to:

- a) Describe in adequate detail the nature of your current professional practice, with particular emphasis on those ethical or legal issues that are of concern or interest to you within your sphere of influence or activity.
- b) Select one particular ethico-legal issue from your previous description and discuss both an applied (i.e. from anecdotal and other possible sources*) *and* a conceptually focused critique of the ethical and legal issues that are related to that issue.
- c) Provide a brief synopsis (1 page maximum) of the main points from both a & b above (to serve as a guide for classroom use in Block Two).

Assignment Number Two

Assignment: **Presentation: Professional responses to a significant ethico-legal issue in** practice

Due Date: 23-24 May 2016

Word Limit: 15 minutes max.

This assignment is worth 20% of your final grade

This assignment focusses on your ability to express the ethical and legal dimensions and concerns of an issue that is of current interest to you *within your own area of practice*. Most importantly, you are also required to offer a satisfactory professionally focused response to that issue.

You are asked to provide a presentation* to your classmates of no more than 15 minutes in total that covers:

- a) Your current workplace situation, with brief references to a range of ethical and/or legal issues that affect your practice.
- b) The main elements of the particular professional issue that you have selected to highlight.
- c) A reasonably precise description and analysis of why exactly that issue carries with it significant ethical and legal concerns in your own professional practice.
- d) At least three possible professional responses to that issue, and conclude with a justification of which particular response you consider to be the most appropriate.
- e) A list of references is required at the end of the presentation.

* A Power Point presentation is normally expected, although possible alternatives will be considered in advance upon request (i.e. before School Block Two).

This assignment meets learning objectives: 1 and 2.

Please submit this assignment to your lecturer as a Power Point print out (3 slides per page, with notes sections) at the end of your presentation.

Assignment Number Three

Assignment: Essay: A critical analysis and theoretical/conceptual response to a currently significant health care issue

Due Date: 24 June 2016

Word Limit: 4000-4500 words.

This assignment is worth 50% of your final grade

This essay will be presented in the style of a completed draft of an article prepared for submission to a suitable journal (which in most cases will be *Nursing Ethics*). You are therefore required to assimilate all of the recently acquired ideas and knowledge from your studies towards this course and utilise them in an article format.

You are requested to:

- a) Examine and consider the various styles of articles in the journal Nursing Ethics.
- b) Select a suitable ethical and/or legal topic for publication (which most likely will be a reflection of the materials within your two previous assignments) and a suitable article style.*
- c) Produce a 4000-4500 word long draft article that would be suitable for publication in that journal. The main aim of the article is to present a contemporary and pertinent critical analysis and theoretical/conceptual response to a currently significant health care issue.
- d) The draft should include all of the normal headings and subheadings (e.g. abstract, introduction, etc.), references, and any other additional materials. *

* N.B. Specific details to undertake this will be provided during classroom time in School Block Two.

This assignment meets learning objectives: 2 and 3

Please submit this assignment as one Microsoft Word file via Blackboard.

Submission and return of work

For submission details, please see individual assessment items. Student coursework assignments submitted by the due date will normally be returned with feedback within three weeks of the due date.

Extensions

An extension to a deadline will only be considered where there are extenuating circumstances. An application for an extension must be made by you in writing/e-mail to the course coordinator at least 24 hours before the due date. When communicating your request you must include the following information:

- name, student number and contact details
- course code
- date of submission and request date for new submission
- reason for extension request

Upon receipt of your request, course coordinators may grant an extension of up to 2 weeks. Any further request for an extension may require Head of School approval.

Penalties

Late assignments or assignments with extensions may be subject to delays in marking and may not receive comprehensive feedback.

A penalty will be incurred for late submission of work where no prior arrangement has been made as follows:

- Work submitted up to 7 days after the due date without an extension will receive a 2 grade penalty. For example a B+ to a B-.
- Work submitted 8-14 days after the due date without an extension will receive a 4 grade penalty. For example a B+ to a C.
