# Prescription

This course investigates key issues in both the fine and decorative arts in France during the eighteenth century at a time when France provided the cultural model for the rest of Europe.

# **Course learning objectives (CLOs)**

Students who pass this course should be able to:

- 1. analyse and interpret the art of this period within the relevant social, political and theoretical contexts;
- 2. gather and organise relevant information and evidence from published material (i.e. secondary sources) and to further your ability to construct an argument using this material;
- 3. present material which is coherent and well-written and which demonstrates an understanding and application of the conventions of academic writing (including appropriate citation, referencing and documentation).

## **Teaching format**

ARTH 315 consists of 24 one-hour lectures and 11 one-hour tutorials. Please note that tutorials are discussion-based and we expect that you do the reading before your tutorial so that you are prepared to participate.

#### Mandatory course requirements

In addition to achieving an overall pass mark of 50%, students must:

- 1. Submit one essay
- 2. Attend a minimum of 8 out of the 11 tutorials
- 3. Present a seminar and submit a seminar presentation write-up
- 4. Sit the final examination

Students must obtain at least 40% in each piece of assessment in order to demonstrate the achievement of all CLOs in the course.

Any student who is concerned that they have been (or might be) unable to meet any of the MCRs because of exceptional personal circumstances should contact the course coordinator as soon as possible.

## Workload

The University recommends that 200 hours inclusive of lectures and tutorials, be given to a 20point course in order to maintain satisfactory progress, i.e. 16 hours/week. Please make sure you can set aside at least this amount of time throughout the course.

Typically, you will dedicate about 30 hours to attending classes, 20 hours to reading for tutorials, 60 hours to researching and writing your essay, 40 hours to researching and writing your seminar presentation, 40 hours to revising course materials in preparation for the final examination and 10 hours to reviewing lecture images and suggested reading.\*.

\* Images from lectures will be available for viewing on Blackboard throughout the course. You are strongly advised to give yourself a regular weekly time to review the images.

### Assessment

ARTH 315 is assessed by means of one essay, one seminar presentation and write-up, each on different topics, and a two-hour examination in which you must answer TWO questions on two

additional topics covered in the course. You will, therefore be tested on four of the five topics of the course. Marking criteria are available on Blackboard.

### Submission and return of work

Essays should be placed in the art history assignment box in the foyer of Old Kirk, Level 3 (ground floor) on the due date. Note that you must attach a *signed* cover sheet to your essay. If you are in doubt about your ability to meet essay deadlines, you must see your course coordinator immediately. Essays will be marked by your course coordinator. A second opinion may be requested in the final assessment of any piece of written work. Notification of marked assignments will be made via Blackboard and can be collected from the Art History office.

### **Extensions and penalties**

**Extensions** for the essay are possible if you are having serious difficulties completing your work. To receive a short extension, contact the course coordinator by email before the 5 pm deadline. For extensions longer than 3 days, you will have to provide written justification (e.g., a medical certificate, death notice, or letter from a counsellor, etc.). Extensions for the seminar presentations will only be granted in exceptional circumstances and with appropriate written documentation.

**Penalties** will apply for late work. 5% will be deducted for work submitted more than 72 hours late; a further 2.5% will be deducted for each subsequent day. Work submitted more than 10 days late will not be marked; the work must still be submitted to meet mandatory course requirements. Late work receives only minimal comments from your marker.
