
Liesle Theron (LLB(Hons) 1998) was appointed convenor of the New Zealand Law Society's Law Reform Committee.

Wellington Community Justice Project



Over 200 law students signed up to be part of the Wellington Community Justice Project in 2015, a student-led society that aims to improve access to justice in the community while providing valuable practical experience for students.

Key initiatives included the Rights Education Project which delivered a record-breaking 152 presentations to young people about their legal rights. The Law Reform team also broke new ground when asked to brief Michael Kirby, former justice of the High Court of Australia, on the current state of animal welfare in New Zealand. The Human Rights team were engaged in a project with the Harvard Kennedy School of

Government on domestic violence against women from a New Zealand perspective, while the advocacy team helped pilot the Welfare Support Project which assists offenders in need of financial support.

Protection of privacy

Recipient of a five-year Rutherford Discovery Fellowship in 2011, Dr Nicole Moreham has recently completed one of the key outputs, submitting the manuscript for the third edition of *The Law of Privacy and the Media*. As well as writing nearly a third of the book's chapters, Nicole is principal editor. The book covers all aspects of the English law of privacy as it affects 'new' and traditional media, including the misuse of private information action, breach of confidence, harassment, intrusion, data protection, copyright, regulatory codes and procedure.

Nicole's next project—and the main focus of her Rutherford Discovery Fellowship—is completion of a monograph on the English privacy tort.

Online bilingual tool first of its kind

The latest output of Te Kaupapa Reo-a-Ture (the Legal Māori Project)—co-led by Māmari Stephens—enables users to explore the Māori language and its vocabulary in a way that has not been easily possible before.

Te Pokapū Reo Ture (the Legal Māori Resource Hub) is an interactive online hub that allows users to browse contemporary and historical Māori language texts, look up word meanings, and test new or old Māori words against an enormous document bank.

Overlooked law could require damp-free rentals



Research by Victoria's Dr Mark Bennett and Dr Sarah Bierre and Professor Philippa Howden-Chapman from Otago University's

public health department has uncovered a potential tool to force landlords to provide damp-free housing.

The Housing Improvement Regulations 1947, which require a home to be free from dampness, were developed to protect people from living in unhealthy homes. However, a review of Tenancy Tribunal hearings by the researchers indicate it is not being used. Since it was published the paper has received considerable attention in media and government circles.

South East Asian IP research

The coordination of intellectual property laws of ASEAN countries is the focus of research being undertaken by Professor Graeme Austin.

Professor Austin is collaborating with Associate Professor Elizabeth Siew-Kuan NG, from the National University of Singapore Law School. Their research is bringing together leading scholars and experts in IP and private international law to consider the need and potential benefits of making IP systems more interoperable in ASEAN and beyond. The research will form part of a forthcoming book which will be published by Cambridge University Press.

Rewriting the law with a feminist lens



Associate Professor Elisabeth McDonald is co-leading research that will cast a feminist light on key judgments in

The Feminist Judgments Project Actearoa, funded by the Law Foundation, is asking scholars to take a feminist perspective to write alternative judgments for a number of significant cases. Alongside each judgment, another scholar will write a commentary, providing the legal, social and political context at the time of the judgment. The outcome of the project will be an edited collection of judgments, published as a book by the end of 2017.



Updates from our centres of research excellence





New Zealand Centre for Public Law



A major highlight for the Centre this year was our Landmarks series, which celebrated a number of key legal anniversaries that fell during 2015.

In June, we put Magna Carta (b. 1215) on trial in the old Supreme Court building. Charged with being "irrelevant and obsolete", the great charter was acquitted—just! Hear the case for and against, as argued by members of the local legal community before Justice William Young, on our website.

In October, we marked the 40th anniversary of the Treaty of Waitangi Act with a cosy "fireside



chat" (minus fireside) between RNZ's Katherine Ryan and Justice Joe Williams. For those who yearn a deep insight

into the social and cultural contribution of the Waitangi Tribunal, this inspirational interview is also available on our website.

November saw a panel of experts discussing the famous decision of Lord Camden in *Entick* v *Carrington* (celebrating its 250th anniversary this year). Refresh your memory of this important case by viewing a brief video on our website—an animated précis of the facts and the important ruling, written by two senior law students.

The New Zealand Bill of Rights Act 1990 also recently entered its 25th year and we have plans to honour this anniversary too.

Other highlights, in addition to our series of public lectures, included a broadcast panel discussion on the Rainbow Warrior (co-hosted with NZCIEL); hosting the 23rd annual conference of the Australian and New Zealand Society for International Law in July, and two symposia held in early December on international humanitarian law and on international organisations respectively.

In November, Dr Dean Knight was appointed as co-director of the Centre (with Professor Claudia Geiringer) and Dr Guy Sinclair as an associate director (with Dr Carwyn Jones). As well, retired Professor of Political Science Dr Elizabeth McLeay has re-joined the Centre as a senior research fellow.

government officials. An open-access book developed from that event is in progress. The book from the second InternetNZ event, 'The Internet and the Emerging Importance of New Forms of Intellectual Property' is also well underway.

NZCIEL's Research Affiliates have been active. In Jakarta, Dr Michelle Limenta, Chair of the World Trade Organisation Program in Indonesia at the Pelita Harapan University, hosted a roundtable event about International Issues and Indigenous Peoples' Traditional Knowledge. Monique Costi presented her work on international financial regulation at the Canadian Council of International Law.

In October, NZCIEL hosted four visitors from the University of French Polynesia who presented papers at 'Culture and Property: Cultural Property?' (an NZCIEL and New Zealand Association for Comparative Law event). Other speakers included the Law School's Māmari Stephens, Professor Mark Hickford, Professor Richard Boast and PhD student Jhonny Pabon.

Other highlights of the year were a panel discussion, including the NZCIEL's inaugural Senior Research Fellow Gary Born, on the legal and political results of the sinking of the Greenpeace's The Rainbow Warrior; a muchin-demand lecture delivered by Associate Professor Meredith Lewis about Mega-Regional Trade Agreements; and NZCIEL Director Professor Susy Frankel discussing the implications of the Trans-Pacific Partnership intellectual property and investment chapters in various media.

Victoria alumnus Max Harris' book review of Gareth Morgan and Susan Guthrie's Are We There Yet? in the April issue prompted an exchange of opinions that has not only been a very popular piece but has been widely circulated and discussed—making an important contribution to the discourse around the Treaty.

Student Monique van Alphen Fyfe won the annual Sir Edward Taihakurei Durie student essay competition for her essay on the proposed reforms to Te Ture Whenua Māori Act 1993, which will be published in the February 2016 issue. The Māori Law Review also sponsored Te Hunga Roia Māori o Aotearoa Hui-a-Tau, publishing a special issue in November with keynote addresses from Chief Justice Sian Elias, Dame Lowell Goddard, Justice Joe Williams, and Māori Land Court Deputy Chief Judge Caren Fox.
